

Privacy Policy

Trophy Property Corp., its affiliates and associates and those for whom it acts as agent, are committed to maintaining the accuracy, security and privacy of Personal Information in accordance with applicable legislation. This Trophy Property Corp. privacy policy (“Privacy Policy”) is a statement of principles and guidelines concerning the protection of Personal Information of our tenants, clients, service providers and other individuals (“you”).

Consent

By submitting personal information to Trophy Property Corp. or its service providers and agents, in writing, verbally or electronically, you agree that we may collect, use and disclose such personal information in accordance with this privacy policy and as permitted or required by law. Subject to legal and contractual requirements, you may refuse or withdraw your consent to certain identified purposes at any time by contacting the Trophy Property Corp. Privacy Officer. If you refuse or withdraw your consent, we may not be able to provide you or continue to provide you with certain services or information which may be of value to you. If you provide Trophy Property Corp. or our service providers or agents with personal information of another individual, you represent that you have all necessary authority and/or have obtained all necessary consents from such person to enable use to collect, use and disclose such personal information for the purposes set forth in this Privacy Policy. From time to time, we may obtain written consent for the collection and use of Personal Information.

Collection, Use and Retention of your Personal Information

Trophy Property Corp. provides a variety of products and services to the public, including but not limited to, real estate brokerage services, real estate agency services, advising with respect to real estate purchase and sale, home and commercial leasing, commercial development, property management, real estate brokerage franchising services and other real estate advisory services. We will only collect the Personal Information that is needed to conduct the service you have requested. Personal Information obtained may include, without limitation, the individual’s name, home address, telephone number, age, income, credit history or other financial information, credit card information, billing and account information, information about your use of our real estate services, and other information about an individual’s family. Personal Information will be retained as part of an individual’s file for a period of time, in the event that future services are required.

Use & Disclosure

Trophy Property Corp. is committed to the protection of all Personal Information collected and used in the operation and management of its activities. Trophy Property Corp. will only use Personal Information for the purpose of providing the service requested. Trophy Property Corp. will obtain consent before disclosing Personal Information for a purpose inconsistent with, or different from, the reason for which the information was originally collected. Trophy Property Corp. will only disclose Personal Information to 3rd parties as required by law. If we need to disclose personal information in any other way, we will obtain further consent as time permits. In certain situations it is legally permitted to disclose Personal Information without consent. Situations involving medical emergency or suspicion of illegal activity are examples of such a situation.

Safeguards & Security

Trophy Property Corp. is committed to upholding the highest standards of safety and security of Personal Information. To help protect Personal Information, Trophy Property Corp. utilizes administrative and technological safeguards appropriate to the sensitivity of your Personal Information. These include locked and limited access to offices, firewall protection and password protected computer systems. Trophy Property Corp. continually monitors and reviews security measures.

Your Right to Access

Individuals have the right to access the Personal Information that Trophy Property Corp. has on file. With satisfactory verification of identity, Trophy Property Corp. will provide the information requested to the individual.

Compliance

Trophy Property Corp. is committed to complying with Canada's PIPEDA (Personal Information Protection and Electronic Documents Act) in all aspects. Questions or concerns regarding the use of Personal Information may be directed, in writing, to the Trophy Property Corp. Privacy Officer. Questions and concerns will be handled in a confidential manner. Realtors and agents of Trophy Property Corp. are members of multiple Real Estate Associations, and are additionally bound to comply with the policies outlined for each Association.
